The **Man-gel** series of books is designed to promote incredible relationships between men and women of all ages. Each book is designed to serve a particular age group or specialty interest.

Submission Agreement

I am submitting to you a proposal, project, story, or other materials, which for the purposes of this Agreement shall be called the “**Material**” and is attached hereto or being submitted through the www.mymangels.com website, which I request The **Man-gel** Project/Stickaforkinit LLC to read and evaluate, and you agree to do so.

I am the sole owner and author of the Material, am of at least 18 years of age, and I have right and authorization to submit it to you, with the understanding and agreement of the terms held within this Agreement. I will indemnify you from any claims that may be made against you at any time by any person, firm or corporation in connection with the Material or any use of it.

I agree that any part of this Material which is not novel or original, or is not legally protectable under the law of literary property, may be used by you without any liability to me; and that nothing in this Agreement will place you in any different position than anybody else with respect to this Material by my submission or your use of it.

I realize that you have access to and/or may create or have created literary materials and ideas which may be similar or identical to my Material in theme, plot, idea, format or other respects. I understand that I will not be entitled to any compensation because of the use of any similar or identical proposal, project or other material. I understand that the review of my Material is, or can be, a lengthy process.

I agree that my Material, once it has been received with this signed agreement, will be evaluated on by agents for Stickaforkinit LLC at a time and place of their own designation, and that I will be notified of its acceptance or rejection within 45 working days of that decision. I agree that you have no responsibility to treat my Material with any added favor than any other proposal, project or other material you have, or may receive.

I realize that if you use this Material and provided that my Material is novel or original or protectable under the law of literary property, and has not been obtained by you from another source, you will publish it in e-book format and/or utilizing traditional printing methods. No other monetary remuneration for the Material will be offered unless this becomes a standard for the **Man-gel** series and it will be treated with no more favor than your standard agreements of a similar nature.

I agree that any claim arising in connection with the subject matter of this Agreement must be brought within six months after your first use of the Material in question and that claim will be settled by a panel of three arbitrators, one to be selected by each of us and they to select a third, all of whom to be persons well acquainted with the publishing industry. Such arbitration shall be conducted under the rules of the American Arbitration Association. You agree that you will appoint an arbitrator within 30 days after you have received written notice of my claim and I shall do the same. The arbitrators' decisions shall be controlled by the terms of this agreement, and I agree that the amount of any award by said arbitrators may not exceed Two Thousand Five Hundred Dollars (\$2500).

I execute this Agreement with the express understanding that you agree to read and evaluate my Material in express reliance upon my agreements and warranties within this Agreement. This is the sole agreement between us and there is no other agreement expressed or implied with the respect to the subject matter of this Agreement. I further represent to you that I have consulted with or had the opportunity to consult with legal counsel of my own choosing prior to my execution of this Agreement.

I understand that whenever the words “you” or “yours” are used above, it refers to agents representing Stickaforkinit LLC.

I have retained a copy of my Material and I release you from liability for loss or other damage to the Material that I have sent to you.

I have attached a copy of my Material to this Agreement and I warrant that all of the important elements of my Material are complete.
